RECOMMENDATION:

Adopt resolution accepting the San Francisco Bay Trail Phase II, Berrellesa Street Project per contract documents and instruct the City Clerk to file a Notice of Completion.

BACKGROUND:

On May 1, 2013, a contract was awarded to R & R Pacific Construction for construction of the San Francisco Bay Trail Phase II, Berrellesa Street Project as per the contract plans and specifications for a total bid amount of \$89,752. No contract change orders were issued. The total price of the 32 contract items, based on the actual field measurements was \$93,575, which is \$3,823 or 4% over the original contract amount. A 15% contingency was provided in the project budget. Attached is the Final Payment sheet.

The Contractor has submitted the Contractor Guarantee and the Maintenance Bond, and agrees to correct any defects as per specifications for a one-year period.

FISCAL IMPACT:

The project was budgeted under Account No. C2002 and was funded by a TFCA grant and local Measure J funds. The project was completed under budget.

ACTION:

Adopt resolution accepting the San Francisco Bay Trail Phase II, Berrellesa Street Project per the contract documents instructing the City Clerk to file a Notice of Completion.


