SUBJECT: Engineer's Report for Lighting and Landscape Assessment Districts
DATE: February 24, 2014

RECOMMENDATION:

Adopt resolutions directing the City Engineer to prepare the Engineer Reports and Assessment Diagrams for the following Landscaping and Lighting Assessment Districts:

- a. 1979-3 (LL-2) (Village Oaks Terrace) for Fiscal Year 2014-15.
- b. 1981-3 (Muir Station Park) for Fiscal Year 2014-15.
- c. 1983-3 (Vista Oaks) for Fiscal Year 2014-15.
- d. 1988-1 (Center Martinez) for Fiscal Year 2014-15.
- e. 1994-1 (Creekside) for Fiscal Year 2014-15.
- f. 1997-1 (Brittany Hills) for Fiscal Year 2014-15.
- g. 2000-2 (Terra Vista) for Fiscal Year 2014-15.
- h. 2001-1 (Alhambra Estates) for Fiscal Year 2014-15.

BACKGROUND:

The Landscaping and Lighting Act of 1972 was incorporated into the Martinez Municipal Code under Section 13.29.010 on March 18, 1981. This allows the City to form assessment districts for the purpose of maintaining landscaping and lighting facilities over public rights-of-way, easements and properties.

Each year in which an assessment is to be levied an Engineer's Report must be filed for each district. The amount of the assessment and its use will be determined in the report. The funds collected can only be used within the boundaries of the district. Any deficit or surplus left in the account from prior years will be carried over and included in the Engineer's Report and may impact the assessments.

There is a three step process for renewing the assessment in existing assessment districts. Authorizing the preparation of an Engineers Report is the first of those steps. Once the Report is completed and necessary assessment levels are determined the Council will be requested to set a public hearing. At the public hearing, the third step, the Council will listen to any protests and make a final decision on the assessment amount.

FISCAL IMPACT:

None at this time. There are funds available in the various district budgets to cover the cost of preparing the Engineer's Report.


