RECOMMENDATION:

Adopt a resolution certifying the results for the November 4, 2014 Consolidated General Election.

BACKGROUND:

Pursuant to Elections Code Section 10262 (b) upon receipt of the results of the election from the County elections official conducting the election, the City elections official shall certify the results to the governing body. The governing body must, no later than the next regularly scheduled City Council meeting following receipt of the results from the County or at a special meeting called for that purpose, do the following:

The City Council must adopt a resolution reciting each of the following pieces of information (Elections Code Section §10263, §10264):

- 1) the fact of the election; and
- 2) the total whole number of votes cast in the city; and
- 3) the names of the person voted for.

WHEREAS, a Consolidated General Election was held and conducted in the City of Martinez on Tuesday, November 4, 2014; and

WHEREAS, the City Council finds that notice of said election was duly and legally given, voting precincts were properly established, election officers appointed, election supplies furnished, and that in all respects said election was held and conducted and the votes cast and declared in time, form, and manner as required by the general laws of the State of California governing elections in cities; and

WHEREAS, the County Clerk of the County of Contra Costa filed with the City on November 26, 2014, a "Statement of the Votes Cast" certifying that he canvassed the returns of the votes cast in the City of Martinez Consolidated General Election held on November 4, 2014; and

WHEREAS, the City Council of the City of Martinez met in the Council Chambers of said City at a Special Meeting, on Tuesday, December 2, 2014, to declare the results of said election.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Martinez hereby declares that said Consolidated General Election was held and conducted in the City of Martinez on Tuesday, November 4, 2014 in time, form, and manner as required by law; that the whole number of votes cast was 11,137; and two City Councilmember seats and one Mayor seat on which the people voted and the whole number of votes which they received are indicated on the "Certification" submitted by Joseph E. Canciamilla, Contra Costa County Clerk-Recorder-Registrar.

BE IT FURTHER RESOLVED that at said Election, Lara DeLaney, Councilmember; Debbie McKillop, Councilmember; and Rob Schroder, Mayor; were elected.
