Subject: Levying Sewer Service Charge for Contra Costa County Sanitation District No. 6

Recommendation

Conduct a Public hearing to adopt Ordinance No. 003 C.S. SD-6 approving the Final Annual Report and prescribing the Annual Unit Sewer Service Charges for fiscal year 2015-16 in Contra Costa County Sanitation District No. 6; adopt a Resolution overruling protests (if required, must be adopted by 4/5 vote).

Background

Contra Costa County Sanitation District No. 6 (District) was formed in 1992 to provide sanitary sewer services to the Stonehurst subdivision in the Alhambra Valley Area. The Contra Costa County Board of Supervisors adopted Resolution 92/57, which formed the district.

Annually the Mayor and City Council, as and constituting The Board of Contra Costa County Sanitation District No. 6, must approve the Annual Report and set the annual unit sewer service charge for the District. The date for the public hearing was set for July 1, 2015, by resolution at the Board meeting of June 3, 2015. The required notices for this hearing date have been published. State law provides that the hearing shall be conducted prior to August 10, 2015, unless another date is set by the County Auditor.

Discussion

Attached is the Final Annual Report for the District. The annual unit sewer service charge provides for continued operation and maintenance of the sanitary sewer system serving the Stonehurst Subdivision. The current annual unit sewer service charge level covers expected District expenses. The funds collected in this District will be used only within the boundaries of the district, and any deficit or surplus remaining in the account from prior years will be carried over to next year's annual sewer system charge.

The total annual sewer system charge for the prior fiscal year for this district was \$91,650. There are not any proposed district boundary changes, new improvements or substantial changes. The proposed total annual sewer service charge for Fiscal Year 2015-16 is \$91,650. The annual unit sewer service charge is proposed to remain at \$1,950.00.

Fiscal Impact

There is no impact to the City's General Fund budget if the annual unit sewer service charges are levied. Alternative funding sources will need to be identified to pay the operation and maintenance costs of the District should the Board not hold a public hearing and approve the annual sewer service charges.





ORDINANCE NO. 003 C.S SD-6

BEFORE THE CITY COUNCIL OF THE CITY OF MARTINEZ, AS AND CONSTITUTING THE BOARD OF DIRECTORS OF CONTRA COSTA COUNTY SANITATION DISTRICT NO. 6

AN ORDINANCE PRESCRIBING THE ANNUAL UNIT SEWER SERVICE CHARGES FOR FISCAL YEAR 2015/2016 IN CONTRA COSTA COUNTY SANITATION DISTRICT NO. 6

WHEREAS, the Board considered all protests and finds a majority protest does not exist.

The City Council of the City of Martinez, as and constituting the Board of Directors of Contra Costa County Sanitation District No. 6, ordains as follows:

SECTION 1. FINAL ANNUAL REPORT. The City Council of the City of Martinez, as and constituting the Board of Directors of Contra Costa County Sanitation District No. 6 (Board), does hereby approve the Final Annual Report for Fiscal Year 2015/2016.

SECTION 2. ANNUAL UNIT CHARGE FOR FISCAL YEAR 2015/2016. For fiscal year 2015/2016, the "annual unit charge" referred to in Section 11 of Ordinance No. 1 is prescribed at \$1,950.00.

SECTION 3. COLLECTION ON TAX ROLL. The Board elects to collect the annual sewer service charge on the Fiscal Year 2015/2016 Assessment Roll.

SECTION 4. EFFECTIVE DATE. This Ordinance becomes effective 30 days after the date of adoption.

SECTION 5. POSTING. At least five (5) days prior to its final adoption, a certified copy of the full text of this ordinance shall be posted in the office of the City Clerk.

Within 15 days after adoption the City Clerk shall publish a summary of this ordinance, with the names of Board members voting for and against in a newspaper of general circulation published and circulated in the City.

SECTION 6. Direct the Clerk of the Board to deliver, before August 11, 2015, a copy of the Report to the County Auditor, as required by Health and Safety Code section 5473.4.

BEFORE THE CITY COUNCIL OF THE CITY OF MARTINEZ, AS AND CONSTITUTING THE BOARD OF DIRECTORS OF CONTRA COSTA COUNTY SANITATION DISTRICT NO. 6

OVERRULING PROTESTS FOR CONTRA COSTA COUNTY SANITATION DISTRICT No. 6

WHEREAS, on the 3rd day of June, 2015, the City Council of the City of Martinez, as and constituting the Board of Directors of Contra Costa County Sanitation District No. 6 (Board), Martinez, County of Contra Costa, California, adopted a resolution fixing the time and place for hearing on the Final Annual Report and annual sewer system charges for the 2015-16 Fiscal Year; and

WHEREAS, said resolution fixed the 1st day of July, 2015 at the hour of 6:00 p.m. of said day at the meeting place of the City Council of the City of Martinez, as and constituting the Board of Directors of Contra Costa County Sanitation District No. 6, in City Hall, 525 Henrietta Street, Martinez, California, as the time and place for hearing protests with relation to proposed improvements and maintenance described in the Final Annual Report and the proposed annual sewer system charge; and

WHEREAS, the City Council finds the protests and objections are made by owners of greater than one-half of the area of the property to be levied for sewer service charges; and

WHEREAS, persons interested, objecting to the formation of said district, to said improvements, including the maintenance or servicing, or both, thereof, or to the proposed annual sewer system charge or to the Engineer's estimate of costs thereof, filed written protests with the Clerk of said Board at or before the conclusion of said hearing, and all persons interested desiring to be heard were given an opportunity to be heard, and all matters and things pertaining to the levy and collection of the annual sewer system charges for said improvements, including the maintenance or servicing, or both, thereof, were fully heard and considered by said council.

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED, AND ORDERED, as follows:

Protests against the formation of said District, said improvements, including the maintenance or servicing, or both, thereof, or to the proposed annual sewer system charge, or to the Engineer's estimate of costs thereof, for Fiscal Year 2015-16 be, and each of them are hereby, overruled.

BE IT FURTHER RESOLVED by the City Council of the City of Martinez, as and constituting the Board of Contra Costa County Sanitation District No. 6, by the following four-fifths vote of all Council members, all of said protests and objections of every kind or nature are hereby overruled or denied; and

BE IT FURTHER RESOLVED the Board Clerk is hereby directed to file this resolution on said project.
