SUBJECT: Martinez Bocce Federation Shade Structure Installation
DATE: July 1, 2010

RECOMMENDATION:

Recommend approval of the installation of two shade structures as shown in **Attachment A** to be installed by the Martinez Bocce Federation after review and approval of construction plans and materials by Public Works staff.

BACKGROUND:

The Parks, Recreation, Marina and Cultural Commission (PRMCC) recommends approval of the installation of two shade structures at the Bocce Ball Courts at Waterfront Park as shown in **Attachment A**. Installation of these shade structures was also approved at the May 6, 2010 meeting of the Joint Powers Authority (JPA) formed between East Bay Regional Parks District and the City of Martinez.

The Martinez Bocce Federation at its expense is proposing installing two shade structures at Bocce Court #1. This is being pursued in the interest of providing a better shade structure than the pop-up canopies currently being used. The materials and manner of construction would be reviewed by our Public Works staff to ensure the construction is sound and meets City standards for shade structures in park. Once the project is completed the Federation will review the success of the shade structure and may return with a request and plan to replace all the pop-up canopies with permanent shade structures as shown in their proposal. This would come back before the JPA, PRMCC and City Council for consideration at that time.

FISCAL IMPACT:

None: Staff time to review and inspect shade structure.

ACTION:

Motion to approve installation of two shade structures by the Martinez Bocce Federation after review and approval of plans and materials by Public Works staff as recommended by the PRMCC.


